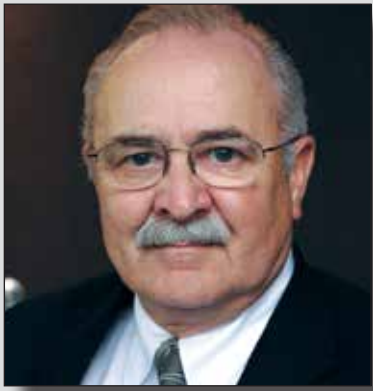

## Lynn Dennis guides the West Seattle Chamber of Commerce full steam ahead

Lynn Dennis knows how business works on all levels, in companies big and small.

She understands the mechanics of running a small family business, because she worked alongside her parents, sister and husband at KMD, Inc. for 15 years. She has also worked in large corporations, like Harbor Properties, which developed major real estate in the city.

Dennis' background prepared her for her current post as CEO of the West Seattle Chamber of Commerce, where she has gained a reputation as a passionate leader.

"She exemplifies women in leadership; she's the whole package," Patricia Throop, vice chair of the Chamber's board and founder of Eldercare Consulting, said.

Throop said Dennis has pushed the organization ahead. "We've been so lucky to get Lynn on the Chamber," Throop said. "She really took the bull by the horns. She's been so phenomenal at getting the board organized and helping define our vision."

Throop said Dennis is a well-known figure in West Seattle.

"Her skill is being able to say, 'I hear your needs and here are solutions and people who can help you,'" Throop said. "She gets to know you so she can be more resourceful. She's a kind, warm, sensitive person—who also knows how to get the job done."

Chamber chair Paul Prentice said the group is glad to have Dennis on board. "We made the best choice we could," he said. "She's been on top of the inner workings of the Chamber. She has a great organizational mind, and she's a great administrator."

Originally from South Carolina, Dennis grew up in small town with a large family. "I had the most unbelievable support system," she said.

Dennis moved with her parents to Atlanta at age 16. She explained that the high school she attended there ranked in

the top four for scholastics in the nation, while the school she left behind ranked in the bottom four.

"I was tutored before, after and during school," she said. "I'm not one of those people that things come to easy. I had to work hard."

Learning the value of hard work at a young age, however, paid off for Dennis.

She took her first internship at a law firm in downtown Atlanta while still in high school. All of the other interns were college students. The next summer, she took a job at a family law firm.

Then Dennis attended Clemson University, where she obtained her bachelor's degree in business administration.

Her next job was at an advertising firm in Atlanta, and she enjoyed diving into her clients' companies to learn about their industries and better understand their markets.

"Then my parents called me," she said.

They had moved to Seattle to start a transportation and distribution company—and asked Dennis to come on board with the new family business.

"They started with two trucks," Dennis said.

The family grew the business to a full fleet with offices in three cities. Dennis also met her now husband Jerry on the job.

Next, Dennis was hired at Manage, Inc to help clients with databases, hardware installations and software development and training. She stayed there for three years until transitioning to the staff of one of the company's clients, Harbor Properties.

The real estate development and management firm needed technical assistance and Dennis was up for the challenge.

She streamlined operations by implementing a whole new software and hardware system to operate both the commercial and residential sides of the business. She later worked for the company as director of strategic planning and training.

"I was able to work with people at the top of the industry," she said. "I've been blessed to work with the best of the best."

At this post, she helped bring Mural and LINK Apartments to West Seattle.

"I walked up and down California Ave, from Morgan to Alki," she said. "I asked everyone, 'What commercial spaces need to be here? What businesses do you want to have in the neighborhood?'"

When Harbor Properties closed in 2012, Dennis responded to a request from a friend, asking her to help the West Seattle Chamber with some organization.

The temporary assignment turned into a full time job when she was hired as CEO two years later.

"I have always been the person behind the person, making them look good," Dennis said. "That was my niche. And in a sense, that's what I'm still doing today."

She simply wants to support the board of directors and build a thriving business

community in West Seattle, she explained.

"It's all about how we make this a better place," she said.

Dennis believes the key to success is being a good listener. "What I do here is listen and connect," she said.

She is also a leader for Weight Watchers—and enjoys helping members become healthier and more confident.

"We spend a lot of time focusing on our weaknesses in life," she said. "When I realized you could take a person's strengths and expand on that, it's the difference between day and night."

With Weight Watchers and the Chamber, Dennis said her goal is to help individuals succeed and thrive.

"I love the people," she said. "There's nothing I wouldn't do for any of them."

## AmazonFresh Pickup opens in Ballard after months of beta testing

Ballardites are finding a new way to buy groceries after the new AmazonFresh Pickup grocery location at 5100 15th Ave. N.W. opened last week.

The store allows for Amazon members to order their groceries lists online or via app, and Amazon employees will pack them up at pickup locations. Within 15 minutes Amazon Prime members can pick up their order.

"I love this. It's so easy," said Ned, 30. Ned said he came from Fremont to get his goods.

Stacey, 24, arrived at the pickup site on a bicycle. She had a backpack and was going in to get her order.

"Having all the items set aside for me and ready to go is pretty rad. I'd be walking around the store looking for stuff and scaring people otherwise."

The store is one of two AmazonFresh Pickup locations—another in SODO—and both are a part of a pilot program.

AmazonFresh Pickup is offered free to Prime members. One feature Amazon uses to maximize efficiency is scanning customers' license plates when they arrive in order to coordinate orders. After placing an order, customers drive up to the site and park. They are identified, and an attendant

confirms the order. Then a short time later the groceries are delivered to the customer and even placed in the vehicle. No need to sign anything. Packaging is much like what a customer would encounter in a grocery store with paper sacks and smaller plastic bags for produce.

The tech giant announced the program was in a beta testing phase at the end of last March, however up until then what was being built at the site where Louie's Chinese Cuisine used to reside was a mystery; Amazon made no announcements until March and did not respond to Ballard News-Tribune (or other publications') inquiries in August as the site in Ballard was being constructed.

The Amazon stores are something the Seattle Times' called a "multipronged approach to unraveling the mystery of profitably selling groceries in the digital age."

Back in April, the Ballard News-Tribune asked Ballardites how they felt about the new store opening in Ballard. Some said that the new store format is an example of e-commerce manifesting in the physical world and the demise of brick and mortar grocery stores. However, more recently, interviewing people near the pick-up location, there were more positive views as customers adjust to an emerging trade in grocery shopping.

## Injured 'Deadliest Catch' fishermen awarded \$1.35 million

After a firework explosion left "Deadliest Catch" fishermen David "Beaver" Zielinski maimed aboard the vessel Time Bandit, King County awarded the fishermen \$1.35 million, concluding over two years of litigation.

An episode of the Discovery Channel's fishing show revealed a firework accidentally blowing up in its launcher Zielinski was holding. The injuries were traumatic and led to multiple surgeries to reconstruct the hand. The incident occurred on Hillstrand brothers' crab boat amid the Bering Sea during snow crab season. The

firework was a Time Bandit-brand.

Unable to fish anymore, Zielinski sued the Hillstrand companies two years ago in King County Superior Court. The case went to trial May 1 and last Tuesday a jury returned a verdict awarding Zielinski the sum. King County Superior Court Judge Jeffrey Ramsdell oversaw the trial. The jury original determined Zielinski should be awarded \$2.7, but it was later reduced because Zielinski was found to be partially responsible for the injuries.

Steven Gibbons, Zielinski attorney, said that an appeal of the order would likely be in order from both sides.



## Police searching for man who attacked woman at Highline High

A dog's growl was enough warning to get its owner to stop casually chatting with a stranger.

At 8 p.m. on Fri., May 5, a woman was out walking her canine companion at Highline High School, 225 S. 152nd St. The campus was busy. A sporting event had just ended and the attendees were piling out of the game and starting to leave the area.

When a man approached her and asked her how to get to the game, she simply gave him directions. He walked away, stood by a tree for a couple of minutes and then returned and tried to pet the dog.

The dog responded with a growl—and the woman picked up her dog and started running away.

The man chased after her, eventually catching up to her and wrapping his arm around her neck, choking her. She struggled to breathe.

Eventually, the victim was able to run away and made it back to her home. She sustained a fractured jaw during the struggle.

She met with police 20 minutes later — and described the man as in his mid 20s, weighing about 180 pounds, with a medium build, brown eyes and short black hair. He wore a black jacket, blue jeans and black shoes. He told her that his name was Juan.

Sgt. Cindi West, spokeswoman for King

County Sheriff's Office, said that the victim did the right thing by following her—and her dog's—instincts.

"As soon as she started to feel uncomfortable, she tried to leave," West said.

Officers are still searching for the man who assaulted this woman.

"A lot of crimes are solved by the people who recognize a suspect and call us to report it," West said. "Police can't see everything and be everywhere. So we rely on the community to help us. That's what we're hoping for in this case."

### Got a green thumb? King County Parks offers sunny garden plots along Green River

If you are dreaming of a garden with a lush bounty of fruits and vegetables and love being outdoors, consider renting your own garden plot at one of King County Parks' community gardens.

King County Parks offers community garden plots for rent at North Green River Park in Kent. Each plot measures 10 feet wide by 40 feet long, and costs just \$50 to rent per season. Plots are renewable from year to year.

The garden plots are located at a bend in the Green River near Central Avenue S. and S. 259th Street in Kent, and are easily accessible from State Route 167. The flat, fertile land features enough sunny acreage for more than 100 garden plots, where fresh vegetables and

flowers can grow for months on end.

Registrations for garden plots are now being accepted from new gardeners. Call 206.477.7275 to request an application form and a chart that shows the available plots. Gardeners can also be assigned a plot by parks staff by downloading a registration form and driving directions.

## Say goodbye to Glacier High School with a walk-through on June 17

Last November, voters approved a bond to build a new middle school on the district-owned Glacier site at 2450 S. 142nd St. in SeaTac. Building the new school means saying goodbye to the structure that housed Glacier High School from 1960 to 1980.

Many Glacier alumni have expressed fond memories of their years there, before the school was closed in 1980 due to decreasing enrollment and SeaTac airport expansion. An alumni group is planning an all-school reunion at Azteca in Burien on Sat., June 17. Alumni are invited to come and celebrate the school and its memories. Please contact Paula Verdi-King (Class of '72) to receive information about the reunion.

Mount Rainier High School Lead Custodian Guy Morford and Woodside Lead Custodian Richard Fisher, both Glacier graduates, have volunteered to lead a tour through the cafeteria, gym and administration building for those who would like to walk through as a group and spend a little time on site with other

alumni between 1–3 p.m.

Hardly a trace of Glacier High School remains at the site because the buildings were later leased by a variety of organizations. Users included the Washington State Criminal Justice Training Center, the City of SeaTac Department of Public Works, and Central Washington University. The site served as the temporary home of Big Picture School. Sound Athletics rented the gym for a number of years.

# Letting Go: Finding Movement & Peace in Pregnancy

For as long as I can remember I have been the type of person that loves control. Controlling what I put into my body for fuel, how I exercise and presenting myself to the world in a certain way has always been a focus of mine. This kind of control can be a good thing to a point, but not when it becomes something that I base my value off of as a person. When I found out I was pregnant the first time, truth be told several thoughts came into my mind....What if I can't work out like I used to? Will my clothes still look good on me as my body grows for the baby? Am I going to be a cute pregnant lady or one that waddles around with a look of disparity on their face? I know these are all negative thoughts that deal with self-esteem, self-worth, and whatever other "self" focused word you want to use, but I can imagine other women have felt this way too and that I am not alone. Pregnancy has taught me more about letting go of my need for control and realizing my own selfishness more than

any other stage of my life. Daily I have had to call upon and remember the promises of my value and worth and practice presence.

**I am loved, I am accepted, I am beautiful, I am enough.**

Remembering and dwelling on these promises or mantras have been huge for me during my first and second pregnancy. Practicing yoga, or staying active and moving in general in pregnancy is not an easy thing. Getting myself to move in some way everyday has not only given me a place to let go and accept myself, but also has alleviated much of the physical stressors brought onto the body by growing a little human being.

**Continuing to practice & move!**

The biggest benefit of prenatal yoga or staying active in pregnancy is learning to let go! Going through pregnancy and its myriad of physical and hormonal changes can be exhausting. Natural worries may emerge about your baby's health, and the imminent transition to parenting can be stressful. There are so many reasons to practice prenatal yoga, and I have summarized some below.

**Benefits specific to Prenatal Yoga**

- Develops stamina and strength
- Balance
- Relieves tension in the lower back, hips, chest, neck, and shoulders
- Calms the nervous system
- Preparation for labor
- Connection with baby
- Increases circulation
- Breathwork practice

No matter where you are in your yoga practice or fitness level, pregnancy will change the way your body moves and responds activity. My favorite thing to remember is that my body was made to carry and birth a baby and that yoga is one way I have found that I can continue to move, breathe, and feel all of the changes my body is making on the mat.

**Try this!**

Warrior 2 strengthens the muscles that support your joints at the hips. This is particularly important during pregnancy, since relaxin—a pregnancy hormone that relaxes your connective tissue—makes your joints less stable. Plus, the powerful nature of the pose will encourage feelings of strength and confidence.

Tip: Position your front leg so that your knee, second toe, and hip are in a line, which reduces pressure on your front knee.

**Meditate!**

**Everyone's swimming to Seattle**

Twenty years ago, Newsweek Magazine famously announced: "Everyone's swimming to Seattle." Pictured on the magazine cover was Washington, D.C., pundit Michael Kinsley, face to face with a salmon and wearing a yellow rain slicker.

That cover appeared during one of Seattle's boom years (1996) when hundreds were moving here to work for Microsoft. Kinsley wasn't just another photogenic poster child, he had been hired to cyberedit Microsoft's Slate magazine.

That was several economic cycles ago. Since then, Seattle has experienced boom and bust, bust and boom and now we're in boom times again. The Seattle Times recently reported that Seattle is now the fastest growing big city in the nation. In a single year (2016), Seattle acquired 2,100 new residents, averaging more than 57 newbies per day and bringing the city's population to 704,352.

Given this overheated population growth, it's small wonder that, despite a forest of construction cranes, we have been unable to keep pace with housing demands nor to stem the wave of rising rents.

The city has been laboring to maximize housing supply—both market-rate and low-income housing—by encouraging development through increased density. But the task of increasing density throughout the city has been fraught with controversy.

Early in his term, Mayor Ed Murray impaneled a closed-door committee of developers (both for-profit and non-profit providers), as well as representatives of labor and business and a few randomly-chosen renters and homeowners. Their assignment: devise a grand plan. What the committee proposed is now being sold to citizens as HALA, Housing Affordability and Livability Agenda.

Key to HALA's Grand Plan is a bargain that, in exchange for greater heights, housing developers must build and set-aside a certain percentage of affordable units, either that or make payments for that purpose. Commercial developers also must contribute. The goal of MHA (Mandatory Housing Affordability) is to produce 50,000 total new housing units in the next ten years, with 20,000 of the units available to lower-income households.

Implementation of the grand plan depends on making more land available for multi-family and high-rise housing units. Within its city limits, Seattle doesn't have much vacant buildable land. That means that increased density will require considerable upzoning—allowing more height and density within the city.

Upzoning within urban villages and centers has received some tacit approval. However, massive changes in zoning and loosening of regulations has encountered pushback. Of particular concern to many residents is the still undecided notion of permitting duplexes and triplexes throughout single-family neighborhoods.

To tell people who presently live here that they must make room for newcomers through significant changes in their communities is not without risk. Nor are the harsh words that have

been uttered asserting that homeowners—characterized as NIMBYs (Not in my Backyard)—are selfish race-focused grouches.

The Seattle Office of Planning and Community Development has been holding outreach meetings to explain HALA implementation. Selling of the program sometimes has the unfortunate aura of group-think. Are the meetings meant to be a one-way dialogue? Or are they an opportunity for residents to provide belated input?

Some have been calling for a pause in Seattle's massive rezoning. Of special concern are opposing goals. On one hand, fliers announce that "no zoning changes are proposed in single family areas outside of Urban Villages." On the other hand, the fliers also state that zoning changes will "expand Urban Villages to reflect a 10-minute walk from very good transit service." In other words, single-family zones likely will be trimmed, carved up, making the "no change" rule meaningless at best.

Seattle is holding an election for two at-large council members and a mayor this year. There are many questions about the HALA program that should be—must be—asked of those who are seeking office. This is an opportunity for voters to assess Seattle's 10-year program, which presently seeks to triple the city's affordable housing production.

One of the largest concerns is maintaining the character of Seattle's unique neighborhoods. To turn every neighborhood into another South Lake Union would defeat the goal of keeping Seattle an attractive place to live for residents and anticipated newcomers alike. To do otherwise would destroy the city's very desirability for those who are swimming to Seattle as well as for those of us presently in the swim.

# Funny nose glasses

It was intended as a simple commercial promoting a baseball giveaway—in which 30,000 Mariners' baseball fans would each receive a free vinyl M's jacket when they came through the turnstiles on August 23rd, 1981.

The commercial was written and produced by the person writing this column. At the time, I was a freshly-minted (for breath purposes) producer for KING TV, the Mariners' broadcast station of the early '80's (carrying a measly 15 games out of 162.)

I thought it would be funny to feature an actual Mariner player as the spokesman—one who starts out doing a straightforward sales job—but is misinformed about what is actually being promoted. The premise had the player

pitching a (non-existent) "Funny Nose Glasses Night"—rather than the actual "Jacket Night" promotion. Laughs would hopefully ensue.

I had decided upon funny nose glasses as the ideal bogus promotional item because the very notion seemed absurd. The usual giveaway items were—and are—always associated with the game of baseball itself: Jackets, bats, caps, etc. They are traditional components of the American pastime.

But funny nose glasses are...well...funny—in an almost universally accepted way that has nothing to do with baseball. Also known as "Groucho" glasses, they look a lot like the makeup style the most famous Marx brother was known for. Even a humorless college professor could generate student smiles by donning a pair. (In fact, many college professors already look like they're wearing them.)

Recently, in a simple Google search—not possible in 1981—I discovered a scholarly psychology article entitled, "The Effect of Groucho Marx Glasses on Depression." Clearly, if such apparel has the benefit of bringing cheer to unhappy people, the same kind of glasses could certainly provide solace to baseball fans of a struggling team. And the Mariners certainly were in the early 1980's.

The player chosen for the assignment was a dandy outfielder named Tom Paciorek. He played 18 seasons all told—

and the best of them were with the Mariners. One year, he finished second in batting average in the American League.

Paciorek was chosen for the jacket night commercial for two reasons: One, he was a quick study at memorizing copy—and two, he was the only player that would agree to do it.

The Mariners' marketing people expected me to put together a commercial that would be quick, slick and professional-looking. They settled for just quick.

Still, the estimable Paciorek knocked the spot out in a couple of takes—as I served as director and off-camera announcer. Here it is—in all its low-definition glory:

When game night rolled around—at least according to team lore—people streaming into the Kingdome were dismayed when they were handed jackets. "We thought we were getting funny nose glasses instead," many reportedly said. (Why exactly they were disappointed is unclear. After all, funny nose glasses do a lousy job of keeping a person dry in a rain storm.)

But the Mariners' marketing department heard so much noise about it that they made a decision: "Let's actually have a "Funny Nose Glasses Night" next season."

And so they did.

It happened May 8th, 1982—designed to coincide with the one year anniversary of the night that the same Tom Paciorek hit the first of his two consecutive ninth-inning, game-winning homers against the Yankees.

A crowd of 36,716 showed up for "Fun-

ny Nose Glasses Night"—the fourth largest turnout of the season—and a bigger crowd than came for an actual big deal baseball milestone two days earlier: Gaylord Perry's 300th career win. (He later wound up in the Hall of Fame.)

The Mariners' manager at the time, Rene Lachemann—even got into the act by wearing a pair of the goofy glasses to homeplate for the traditional lineup exchange. Less well remembered: The M's lost to the Yankees that night, 9-4.

All these years later—this week in fact—the Mariners are again staging a "Funny Nose Glasses Night." But there will only be 5,000 pairs given away this time—so the promotion could inadvertently turn into the first ever "Crying Kids Who Missed Out—And Their Parents Are Not Happy About It...Night."

Footnote: Even though he was as responsible as anyone for that very first "Funny Nose Glasses Night", Tom Paciorek wasn't around to be a part of it. By then, he'd been traded to the Chicago White Sox. But that turned out just fine for him—because today he is a Chisox baseball broadcaster.

And speaking of the Windy City, I need to contact someone at the Mariners again—about my idea for "Whoopee Cushion Night."

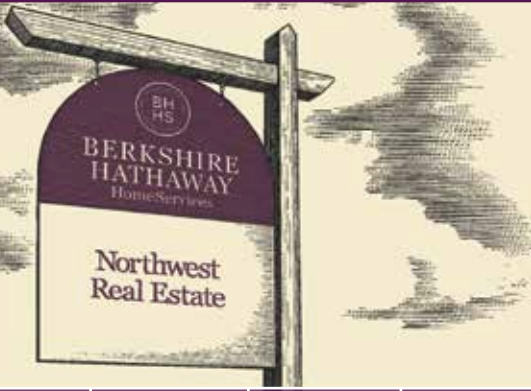

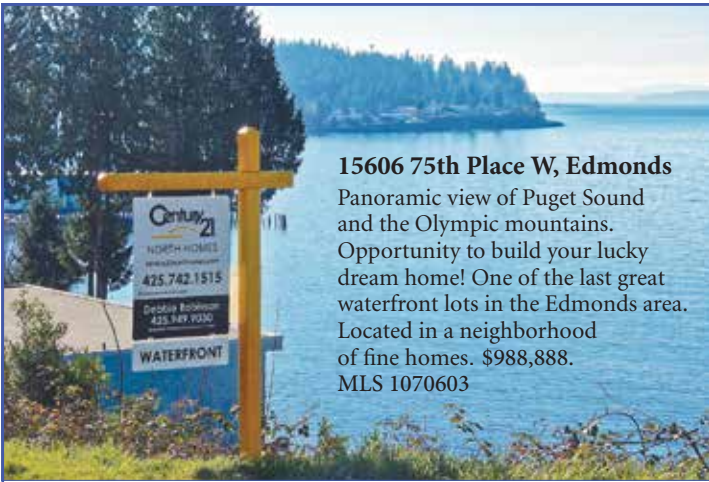

being less At Large in Ballard and more...at large. Right away some ideas started to bubble up in me, ones that had seemed drowned in weekly deadlines and the changes in my life since my first column back in 2007. The mystery of a garden growing in a vacant commercial lot near the Ballard Goodwill, my mother's encounter with Garrison Keillor.

Part of the problem is that lately I've just wanted to garden my way out of worrying about my take on a constant erosion of what constitutes democracy, and it's been hard to find positive story material beyond my happy tomato plants. Where are the sea lions this year? Why aren't they singing from the buoy? Plus I get depressed in June. It's so light all the time, especially when there are too many sunny days in a row.

After saying goodbye to Ken Robinson, I no-

ticed an alert on my computer about a fire in a single-family residence in Ballard. Probably because of that west wind I hadn't heard the sirens. I sent a text to News Reporter Shane Harms (did we have computers or texting ten years ago? We didn't have Shane Harms yet, but at least he'd been born). He asked if I was nearby. Nearby, and familiar with the house, an absolute beauty (1911, Hipped Roof, Historic Category 1) from the Mapping Historic Ballard project.

So 10 minutes after announcing my summer sabbatical I was next to Captain Roddick as she set down her chain saw "Minimal damage," she said upon inquiry. "Well, not minimal," she amended. "Mostly the wood porch and back wall. We did have to cut into the roof." The cause was charcoal briquettes from the previous evening left on or near the back porch, "Not quite spent. You wouldn't believe how often this happens."

"So not spontaneous combustion," I con-

firmed with Battalion Chief J.M. Havner, Fire Station 18. Part of the reason I'd heeded my fire engine-chasing instincts was the recent outbreak of nearby fires due to spontaneous combustion, including one that started in a plant container.

"Not this one," Havner said, "It's barbecue season. Think, safety, safety, safety. Let everyone know to be careful."

So I did what I needed to do. Got back to my laptop by the open door and wrote this column. Because I'm not quite spent either. I may not be on these print pages, or the "front page" of the website consistently for a while, but I'm not going anywhere. So be careful.

Plus less feedback proffered to me in the produce section at Ballard Market. He let me whine for a bit, talked me up, talked me down, and then we agreed on a summer sabbatical. But especially given that it's summer we agreed to leave the door open, just the way that my front door is now wide open to the flies and a westerly afternoon breeze right now. "If there's something that lights you up and you need to write about this summer, just let me know," he said.
